1. Introductions

Chair Todd Janigo called the meeting to order at 1:33 pm. All meeting attendees introduced themselves.

3. Guest Speaker: Stephanie King, WisDOT, Superior Project Development

- **EAST 2N ST UPDATE**

Stephanie explained that this was going to be a huge undertaking. It will be causing delays and detours for a significant amount of time. The overall project includes the resurfacing on E 2nd St from 2nd Ave E to 53rd Ave E. It will be split into 2 parts: 2nd Ave E to 31st Ave E (construction year 2020) and then 31st Ave E to 53rd Ave E (construction year 2021).

The first phase of the project will include spot concrete repairs and manhole and inlet repairs. Then the concrete will be coarsely ground and the overlaid with asphalt. Also included will be traffic signal replacements, freight mitigation and sidewalk curb ramps updated.

There will be many detours not only for the roadway but for trails and park accesses including pedestrian and bicycle accommodations. WisDOT is looking for suggestions for safe detours and alternative routes for vehicles and trucks. If you have any of those suggestions please contact WisDOT or attend one of the public meetings.

4. 2018 – 2021 Superior Area TIP Amendment #7 & 8, Dena Ryan

Dena explained that the Amendments are for the purchase and installation of a flashing light (beacon) warning truckers that the upcoming railroad bridge on CTH Z is less than 12" high at its peak in hopes that trucks will use an alternate route instead of hitting the bridge. (2018 design and 2019 installation)

6. 2018-2022 Duluth Area TIP Amendment #4, *Chris Belden*

Chris explained that this amendment was presented to the MIC too late for consideration at this meeting. The 8th/9th Streets project has increased in costs by over \$1 million. This increase is due to underestimating costs.

In order to provide for the required opportunity for public comment a special phone in meeting has been scheduled for Thursday, March 29th @ 4 pm.

There was some discussion and questions concerning the specifics of a \$1 million plus increase for this project. John McDonald gave a brief explanation stating that the original estimate was correct for just a “mill and fill” project but has changed to include some curb & gutter replacement, ADA pedestrian upgrades, SRTS upgrades needed to accommodate intersections near Myers Wilkins Elementary and some utility & storm water repairs.

7. MIC AREAWIDE BIKE PLAN

James explained that he is painstakingly taking the time to provide a direction for those looking at this plan long after we are all no longer available to ask “why”, “where” and/or “when”. It will not state that a particular type bike facility should be installed “here”. It will provide a guidance as to whether or not accommodations should be made for bikes at this location in the future. We are hoping that eventually the numerous trails across the area will be connected and provide safety and comfort to those from 8 to 80 to ride their bikes. The MIC is still working on a map that will be making the rounds to the jurisdictions for their input before a final draft of this plan is presented for comment and then approval.
