






History of Sky Harbor



- 1931  ● First landing and takeoff performed at Sky Harbor.
- A sand runway was constructed to incorporate land-based operations and later was stabilized with clay and seeded with grass.
- 1946  ● City leases the airport land to private owners, Sportsmen Airways Inc.
- 1948  ● The airport was fully licensed with the CAA (Civil Aviation Administration).
- 1963  ● The City of Duluth took over ownership and constructed a paved runway in the place of the sod runway.
- 1969  ● The city chartered the Duluth Airport Authority and the DAA took over responsibility of the airports in Duluth.
- 1985  ● A parallel taxiway was constructed.



Quick Facts

 - Significant to national air transportation
 - Eligible to receive Federal Airport Improvement Program (AIP) grants.
- \$1,601,413 in annual economic impact
- 24.46 jobs (direct, indirect and induced) 2013.

- 1 land runway (14-32) and 2 sea runways.
- 32 based aircraft
- 8 hangars
- 14,000 ops per year
- 24/7 Fuel + Pilot Services
- Underwing Camping
- U.S. Customs- 500+ people processes annually (as of 2013)

- 2,600' Runway
- LED lights (runway & taxiway)
- Constructed to Coexist with Environmental
- Protect Old-Growth Forest & Native Plants
- Remove 10 Acres of Invasive Species
- Enhance Nearby Aquatic Habitat.
- \$13.2M Project
- Completed 2020

On-Going Monitoring of Mitigation

- Equal public value
 - Replace 7 acres of open water habitat
 - DNR and Army Corps of Engineers requirement
- Dune planting, shoreline planting, and aquatic habitat cribs - complete
- Ongoing: invasive plant management and aquatic vegetation install
- Expected to finish 2024

- Project completion January 2024

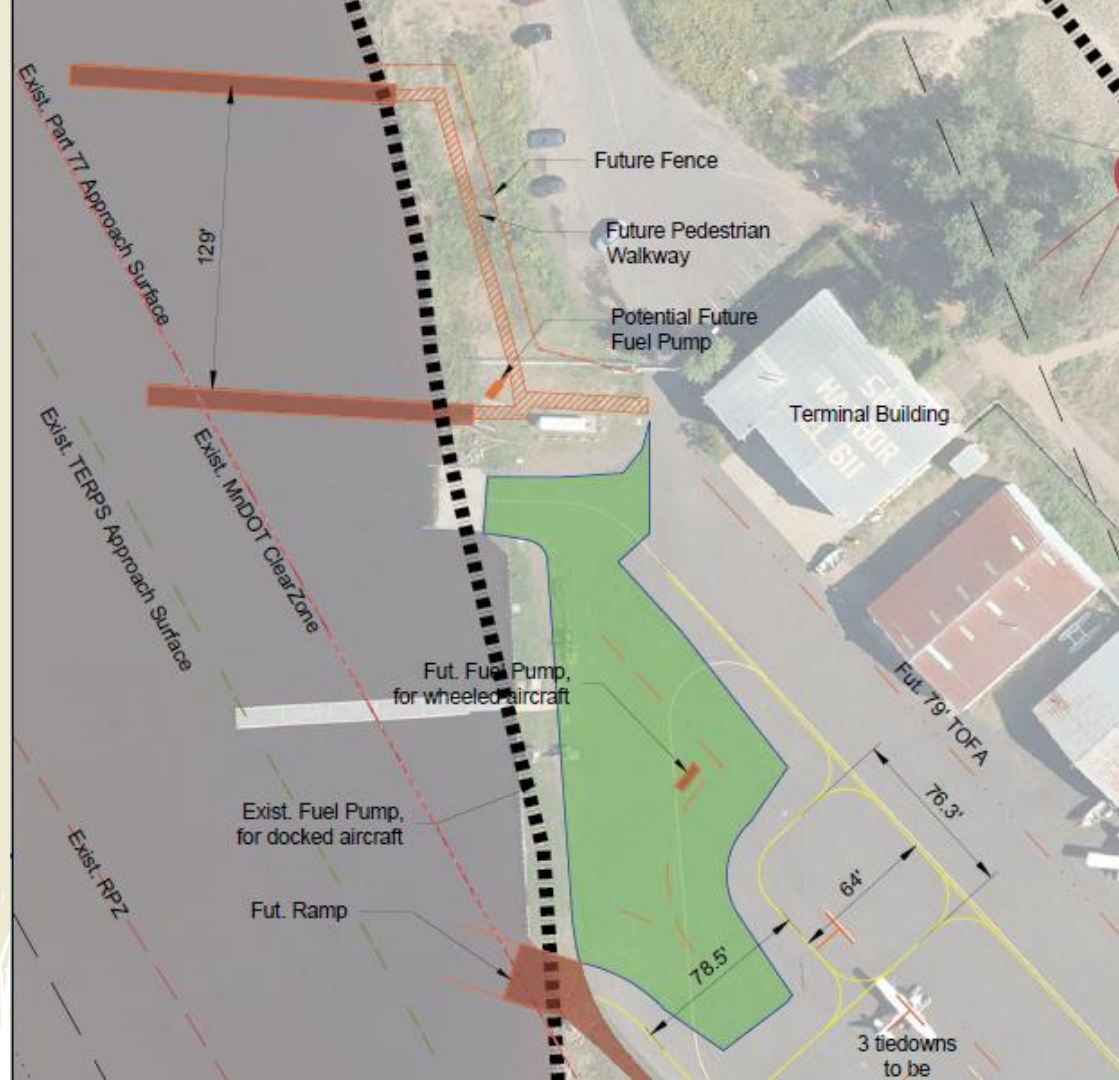
Arrivals/Departures Building

- Dictated by Demand
- Opportunity to Host Seaplane Fly-ins



Hangar Expansion

- Dictated by Demand
- Addition Ranch Hangars Suitable for Cesena 172 or Cirrus SR 22, etc
- Up to 10 Hangars Possible
