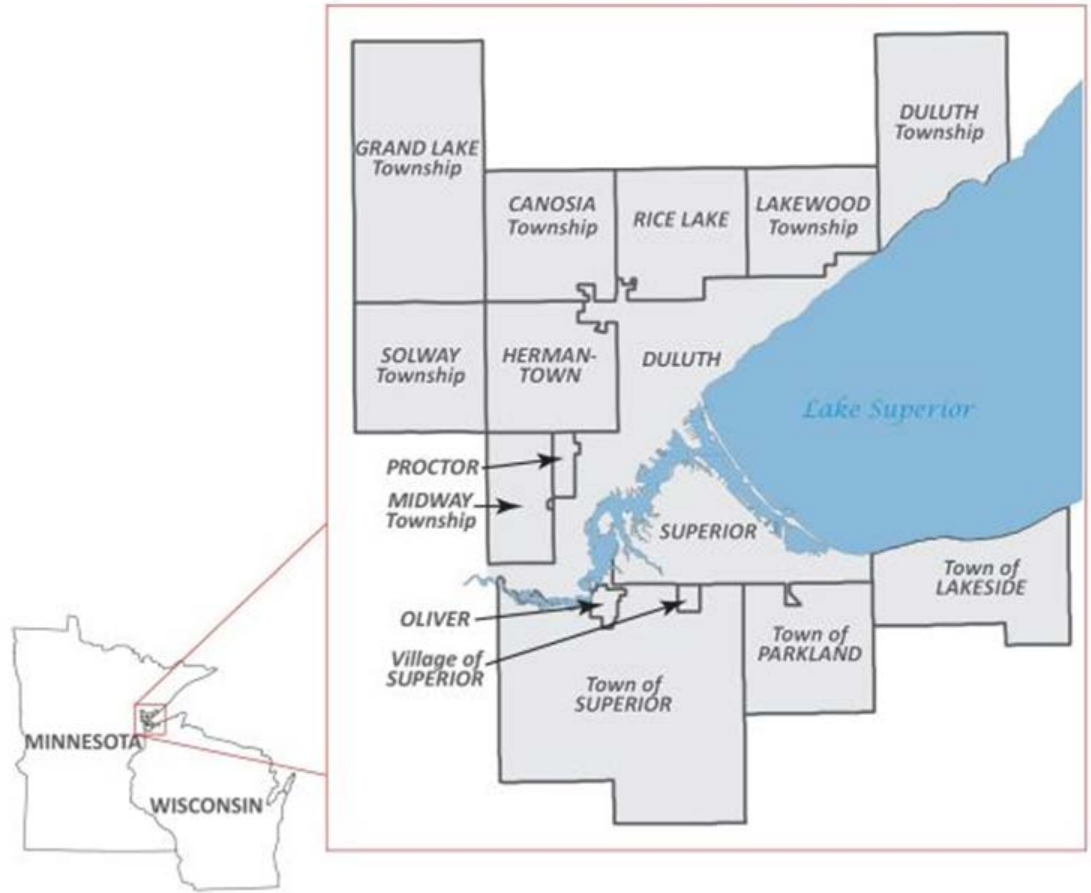

- Scope will include just the first steps (to continue into 2025)

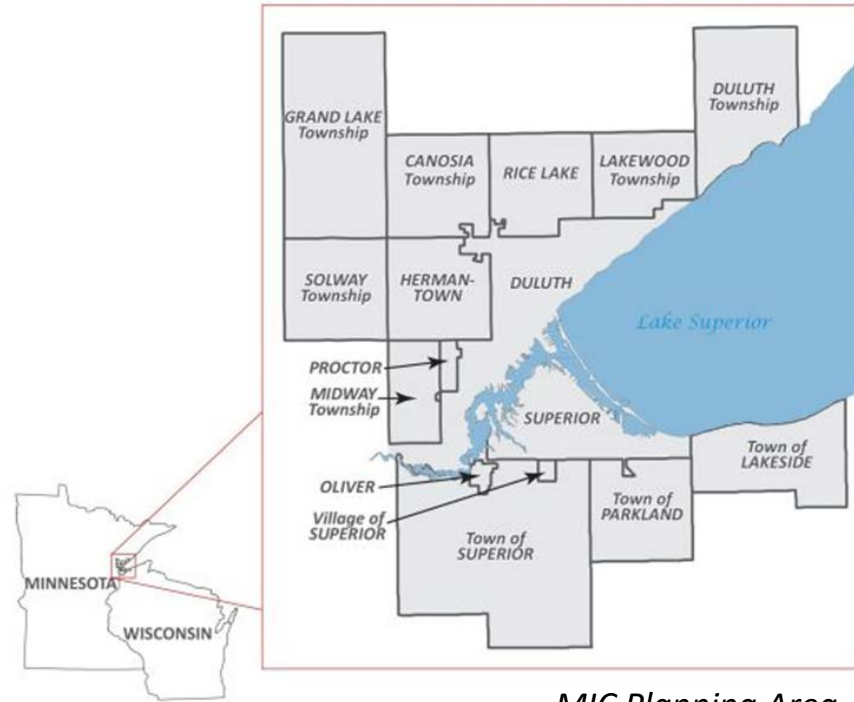
Final Document
