## Transportation System Perceptions

## **Traffic congestion**

 Light at middays and weekends and moderate during morning and evening commutes.

#### **Transit Service**

- Perceived as average
  - Few survey respondents are bus riders.

#### **Pedestrian Facilities**

 Sidewalks, crosswalks, pedestrian traffic signals, etc., are considered poor to average.



## Transportation System Perceptions

### **Bicycle Infrastructure**

- Bike riders in the region do not feel as though biking is safe or convenient
  - Even non-cyclists feel that bike infrastructure is poor



## Transportation Issues and Opportunities

## Snow clearance, particularly as it affects walking

Identified by a strong majority of respondents

### **Spot traffic congestion**

On a small number of road segments and intersections

### **Excess road capacity**

- Reallocate pavement or right of way to walking, biking, or transit
- Reduce pavement or right of way to save costs and minimize environmental impacts

### **Limited funding**

Requires prioritization of initiatives



## Transportation Issues and Opportunities

#### **Oversized trucks**

- Need to be able to accommodate as port activities grow
- A truck bypass would benefit all transportation in the region

## Reliable, base system for walking

- Should be a key feature of the 2050 plan
- Fix gaps in the sidewalk system, determine year- round maintenance
- Especially critical as this area's population ages.

### Continuous, safe east-west greenway or bike lane

Could dramatically improve cycling

### **Transit system**

Has been improved, but still perceived as a "second class" mode



## Transportation System Priorities & Values

### Critical Issues to be Addressed

- Maintaining infrastructure in good working condition;
- Improving conditions for walking, biking, and transit;
- Transportation safety identified as the region's number one priority

## **Key Themes**
