

- Safety Action Plan Update 2024 AECOM and the area jurisdictional partners continue to meet as now, with our recently added funds in the Work Program, we have enough of a budget to finish the detailed data analysis phase. We will have a list of projects throughout the MIC area with strategies identified to mitigate them. Separately, we'll continue to meet with FHWA in Minnesota as we prepare to launch the larger federal grant, most likely not until the end of the year or early next year.
- Duluth 40th AW / Piedmont Ave & 24th AW The City and the County are meeting with area stakeholders to discuss components of these two projects: one, a corridor and one, an intersection. First, 40th AW from the freeway to the railroad crossing just below the large hill climb. This is to be a reconstruction project for 2026. The objective here is to design a new multimodal roadway layout including the future intersection control at Grand. Second, at Piedmont and 24th AW, determine if the temporary signal at this location should remain in place once the Twin Ports Interchange work concludes, plus determine the best signal control for the long term.
- Association of Metropolitan Planning Organizations (AMPO) Washington DC Spring Meetings Next month, I'll be participating in a series of meetings with my colleagues across the country as work on maintaining existing and developing new policy initiatives within the federal transportation bill. Meetings are set up with many partners including: Federal Highway and Transit, House and Senate leaders tasked with the bill, and other like entities in DC such as the National Leagues of Cities and the National Association of Development Organizations. One key new initiative that is quickly gaining ground is for the MPOs to directly receive our planning funds right to our host agency (as opposed to the funds first going through the states). This will be interesting as it plays out. Many MPOs due to their host setup already receive several federal grants directly. Unnecessary oversight and related expenses could be avoided. ARDC, in our case, has handled federal grants in the past and can certainly do so again.
- St Louis Co. Highway Safety Improvement Awards Based on the solicitation from last year out of this state operated program, the County received three federal grants totaling approximately \$1.3M. Included are the following:
 - 1) Edgeline painting (6") of county roads in the MPO area.
 - 2) Midway Rd and Becks/Halie (just south of I-35) added turn lanes and lighting.
 - 3) Midway Rd and Rose Rd (south of 194) added turn lanes and lighting.



3. 2024 MNDOT SAFETY PERFORMANCE MEASURE (PM1) TARGETS*

The MIC will be asking to adopt the most recent Performance Measure 1 2024 baseline and targets. These performance measures are calculated by MnDOT on a semi-annual basis, and are incorporated into both the Duluth Area TIP, as well as the Long Range Plan. These current targets and baseline are as follows:

5. LONG RANGE MTP 2050 – PROJECT SCORING METRICS

The MTP team will provide an overview of the project evaluation framework proposed for the development of *Sustainable Choices 2050*. The presentation will highlight the proposed data-driven metrics along with a description of planning emphasis areas that will be used to help refine the project scoring. The project evaluation framework builds upon the December 2023 presentation which included an overview of performance-based planning, discussed the importance to the regional transportation planning process, and presented similar examples.

6. FY2028 DULUTH AREA TIP STBGP PROJECTS & TRANSPORTATION ALTERNATIVES (TA) PROJECTS OVERVIEW

Duluth TIP FY2028 STBGP Projects Update

The City of Duluth has applied for STBGP funding for their part of a City of Duluth/MnDOT reconstruction project for Central Entrance from Trinity Rd to Mesaba. STBGP funds are just one portion of this project, to include, but not limited to city legs of intersections associated with this project, as well as bike and pedestrian improvements. The City of Duluth STBGP application is in the amount of \$1,200,000 total project cost for this project.

Additionally, Hermantown has applied for STBGP funding for a portion of the Munger Trail connection. This project is a reconstruction of Hermantown Rd from Okerstrom Rd to Haines Rd, from a rural to an urban roadway typology (to include curb-and-gutter and stormwater infrastructure). This project includes an enhanced crossing across Hermantown Rd of the Munger Trail, to include RRFBs and other crossing improvements. The Hermantown STBGP application is in the amount of \$2,350,000 total project cost for this project.

TA FY2028 Projects Update

There are four Transit Alternatives (TA) project applications for FY2028 submitted to the Northeast Minnesota Area Transportation Partnership (NEMNATP) that are within the MPO planning area. The total requested amount is \$1,966,420.76 in the MPO area, with \$1.8M total TA funds available in the region. These projects are to be vetted and approved by the NEMNATP in April 2024 and include: Hermantown Community Connector Trail (Segment 1 & 2), Duluth Transit Authority transit amenities, Rice Lake Rd (CSAH 4) Trail, and 40th Ave W (CSAH 91) Bike and Pedestrian Improvements.

7. 2025 MINNESOTA CARBON REDUCTION PROGRAM (CRP) FUNDS PROJECT ANNOUNCEMENT

The Carbon Reduction Program (CRP) is a relatively new funding source, authorized by the Infrastructure Investment and Jobs Act, to provide funds distributed by population size with the



aim to reduce carbon emissions by either enhancing existing programmed projects, or funding stand-alone projects. This program is funded through FY2028.

The Duluth-Superior MIC has the discretion to select projects for the allocation of these funds each fiscal year. Currently, there is consensus amongst the MIC's CRP working group to allocate \$370,000 in FY25 funds to assist the City of Duluth with their planned West Superior Street corridor reconstruction project, in addition to the federal RAISE grant for this project. Documentation is still being finalized for this funding award, and work continues to determine the best candidates for FY26, FY27, and FY28 funds from this source.

8. BICYCLE PEDESTRIAN ADVISORY COMMITTEE (BPAC) UPDATE

The most recent quarterly meeting of the Bike and Pedestrian Advisory Committee (BPAC) met on Thursday, February 1st, 2024, with 24 people in attendance (12 voting members, 12 others). There were no voting items or resolutions at this time. Items discussed included All Season Design, a Safe Systems Approach, a presentation by Tanja Mattonsen of St. Louis County, and a presentation by Mike Wenholz, MIC Principal Planner, regarding priorities for the MIC's Long Range Transportation Plan. Going forward, items the BPAC are tracking include: Bike Plan and Pedestrian Plan Updates in 2024 and 2026, respectively. Other projects BPAC is tracking include: Blatnik Bridge, 40th Ave W Corridor, London Rd, and various grant funding opportunities.

10. PROJECT UPDATES

• Administrative Modification #6 to the 2024-2027 Duluth Area TIP

MN 23 in Duluth, W 5th St to 121st Ave W

This modification, approved by MIC staff, is a reduction in total project costs due to updated cost estimates. The total project cost has been reduced by \$400,000, \$325,680 of which is from federal funds, and the project remains fiscally constrained, with no change to the project scope.

• Administrative Modification #7 to the 2024-2027 Duluth Area TIP

I-35 in Duluth, Lake Ave to 21st Ave E

This modification, approved by MIC staff, is a reduction in total project costs due to updated project costs and better unit price costs. The total project cost has been reduced by \$831,000, and the project remains fiscally constrained, with no change to the project scope.



• Amendment #1 to the MIC's 2024-2025 Work Program and Budget

As described in the January meeting materials, the MIC had a \$100,000 balance left over from our 2023 budget, due to being short-staffed after the departure of our Senior Planner early last year. We proposed to carry that amount over to the 2024 budget by amending our approved 2024-2025 UPWP (\$75,000 to complete Phase 3 of the MIC-area Safety Action Plan and \$25,000 to complete the 2050 update of the MIC's long-range Metropolitan Transportation Plan).

The Policy Board approved this amendment at the January meeting, and we subsequently received the required state and federal approvals. We are now working to amend our contract with AECOM, the consultant currently conducting the technical work for the MIC-area Safety Action Plan and assisting MIC staff with the 2050 MTP update, to update the scopes of work and budgets for those projects.
